PAGEANT RULES

Attach cashiers check or money order to this application. **DO NOT SEND CASH OR PERSONAL CHECKS.** Personal checks will be returned. Applications submitted without entry fee will not be accepted. If sending through certified mail, please **DO NOT** check "Return Receipt for Merchandise". Entry fee will be returned when contestant limit is filled, if entry arrives after deadline date, or the pageant is cancelled. You will be officially notified of your acceptance.
- Deadline for entries received is 6:00 pm Thursday, September 15, 2016. COMPLETED** entry form with entry fee and current full-length photograph should be mailed to the location listed below —professional photograph not required. This will also be your contact person if you have any problems or questions about the pageant. Also, you will be contacted by a pageant official prior to orientation. Those promoting the pageant are not responsible for any entries received after the deadline. All contestant entry forms and photos and all photos taken during the pageant and during any and all race related events become the property of the pageant sponsors and cannot be returned.

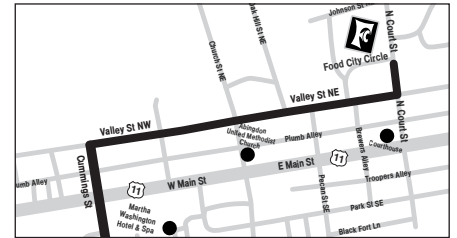

DIRECTIONS TO ORIENTATION MEETING

I-81 to Exit 17 — Turn left (if traveling north bound) or right (if traveling south bound) at end of ramp onto Cummings St. — Travel approximately .9 mi. Turn right onto Valley St. — Travel approximately .4 mi. Turn left on Court St. NE. — Food City Circle will be first entrance on the left.

NON TALENT COMPETITION



- An orientation and mock interview will be held Sunday, September 18, at 2:00 pm at the K-VA-T Corporate Support Center, 1 Food City Circle, Abingdon, VA 24210 (GPS: 351 Court St.) **It is mandatory all contestants attend orientation.** Failure to attend will result in automatic disqualification. Bring a pageant style swimsuit to this interview for Pageant Committee approval. **No 2-piece swimsuits will be permitted.** Photographs will be taken of all entrants during orientation, please wear job interview attire. Photographs will be printed in pageant program book. Rehearsal will be held Friday, October 7, at the Paramount Theatre on State St. It is mandatory that all contestants attend all rehearsals and meetings scheduled. Failure to attend rehearsals will result in **automatic disqualification.** The Miss Food City 500/300 pageant will be held on October 8, 2016 at 7:00 pm at the Paramount Theatre on State Street in Bristol, TN.
- Contestants agree that if selected as a finalist, they understand the requirements of the winner and will be present at all events specified above by sponsor. The winner should not hold any other title that may interfere with her responsibilities as Miss Food City.
